The old VAT rate on solar panels was either 5% or 20%, depending on the situation. Installations would come with a 5% VAT rate if they were carried out at a household with a resident who was aged 60 or over or received a qualifying benefit.

In Northern Ireland, the incumbent reduced VAT rate of 5% will continue for the installation of solar panels and other specific energy-saving materials. When will the VAT rate on solar panels revert to 5%?

The zero VAT rate on solar panels is set to continue until 31 March 2027, after which it will revert to a reduced rate of 5%, aligning with the government's long-term financial and environmental strategies.

When does 0% VAT apply to solar panels?



This zero-rate VAT policy was introduced in April 2022 for England, Scotland, and Wales, and extended to Northern Ireland from May 2023. The 0% VAT rate applies to both the cost of solar panels and their installation. When will this VAT exemption end?
