If the solar panels are purchased from one provider and installed by another, the higher rate is charged. Additionally, maintenance or repairs post-installation are also taxed at the standard rate. Prior to the 0% rate introduction, VAT for solar panels varied between 5% and 20%, based on specific conditions.

Does 0% VAT apply on solar panels & batteries?

While the UK government's 0% VAT policy on solar panels and batteries offers significant savings, there are specific exceptions where this rate does not apply: Secondhand materials: The 0% VAT rate only applies to brand new solar panels and batteries. Secondhand or used materials are subject to the standard VAT rate of 20%.

Do I have to pay VAT if I install a solar panel?

If you're planning a DIY solar panel installation, you won't be eligible for the 0% VAT rate. Only new materials supplied and fitted by a MCS registered installer are eligible for this scheme, so you'll pay 20% VAT on all materials you purchase.

Will VAT be scrapped for solar panels?

Regarding domestic solar panels, the scrapping of VAT and other solar panel grants, such as the Smart Export Guarantee, is expected to help bear the installation cost of solar panels, which many UK households find very expensive. For residential properties, installing solar panels is subject to a 0% VAT charge.



When will 0% VAT on solar panels come into effect in Northern Ireland?
