For residential properties, installing solar panels is subject to a 0% VAT charge. However, it's important to note that the VAT reduction only applies if you're having the solar panels installed by a professional.

Will VAT be scrapped for solar panels?

Regarding domestic solar panels, the scrapping of VAT and other solar panel grants, such as the Smart Export Guarantee, is expected to help bear the installation cost of solar panels, which many UK households find very expensive. For residential properties, installing solar panels is subject to a 0% VAT charge.

What is the VAT rate on solar panels?

The old VAT rate on solar panels was either 5% or 20%, depending on the situation. Installations would come with a 5% VAT rate if they were carried out at a household with a resident who was aged 60 or over or received a qualifying benefit.

When does the 0% VAT on solar panels end?

The 0% VAT on solar panels is set to end on 31 March 2027. From 1 April 2027, the VAT rate is due to rise to 5%. There's been no move to extend the 0% rate beyond March 2027, though ultimately this decision will depend on how successful the policy is.

Can a business recover VAT paid on solar panels?

Businesses can recover the VAT paid on installations through input tax claims if the panels are used for taxable business activities. This can mitigate the impact of the initial 20% VAT charge. However, if the business activities are exempt or the solar panels are used for non-business purposes, VAT recovery may not be possible.

Do you have to pay VAT on solar export income?

There's no VAT on solar export income that households earn, though any VAT-



registered companies with commercial solar panel systems must include a 20% rate in their sales. You may have to pay income tax on your export earnings though, depending on your situation.
