What is a solar panel rebate?

The solar panel (PV) rebate is a discount of up to 50 per cent of the purchase cost to install solar panels, to a maximum of \$1,400. It is calculated after any other discounts have been applied, including Small-scale Technology Certificates. You can also apply for an interest-free loan for the equivalent to your rebate amount.

How can Victorians save money on solar panels?

Through solar battery rebates and loans, more than 20,000 solar battery systems have been installed across Victoria. The Government has helped Victorian families slash \$1 billion off the installation of solar panels, energy efficient heat pumps and batteries – saving hundreds of millions off Victorian energy bill.

Do you offer a solar rebate?

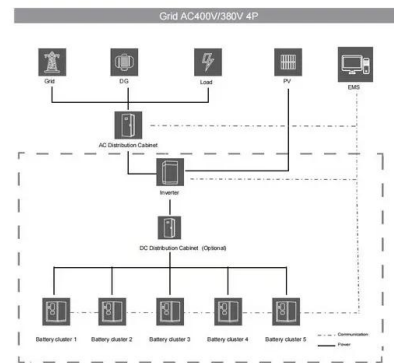
