In 2017, DOEE partnered with the Department of Employment Services (DOES) to launch Solar Works DC, a solar job training program designed to prepare District residents for careers in solar and related industries.

What is solar for all?

Solar for All aims to bring the benefits of solar energy to 100,000 low to moderate income families in the District. DOEE is partnering with organizations across the District to install solar on single family homes and develop community solar projects to benefit renters and residents in multifamily buildings.

Who are the key partners for solar projects in DC?

Key partners: DC Sustainable Energy Utility, Solar United Neighbors, Groundswell, GRID Alternatives Mid-Atlantic, Solarize DC. Promising practices: No-cost solar project installations, program codified in law, collaborative program development, prioritize developing community trust.

Who funds solar for all?
