The Environmental Protection Agency announced Thursday it is terminating its \$7 billion Solar for All program that was designed to bring renewable and affordable energy to low-income communities. Sources confirmed to CBS News earlier this week that the agency planned to scrap the program. Solar for.

Solar for All is a \$7 billion competitive grants program administered by the U.S. Environmental Protection Agency. In April 2024, EPA awarded 60 grants to states, territories, Tribal governments, municipalities, and nonprofits to expand the number of low-income and disadvantaged communities primed.

This disparity reflects a persistent gap in clean energy access across the country.<sup>1</sup> With Solar for All (SFA), the promise is simple but transformative: bring solar power to nearly one million American households that have been historically left out of the clean energy transition.<sup>2</sup> This \$7 billion.

Solar for All is a component of the Inflation Reduction Act that aims to make affordable solar available to disadvantaged communities across all 50 U.S.



states. Under the \$7 billion Solar for All program, the 60 grant recipients will create new or expand existing low-income solar programs, which.

Switching to solar energy can feel like a dream for many families—lower bills, clean energy, and the satisfaction of reducing your carbon footprint. But for some, it's a dream that feels out of reach, especially for low-income households and communities that have historically been overlooked when. What is solar for all?

"Solar for All is an investment in energy infrastructure that's going to serve that residential customer that's going to keep energy rates in America more affordable and more fair," she said. Solar for All awarded grants in August 2024 to 49 state-level agencies, six tribes and five multi-state award recipients, according to the EPA.

What is the \$7 billion solar for all program?

Under the \$7 billion Solar for All program, the 60 grant recipients will create new or expand existing low-income solar programs, which will enable over 900,000 households in low-income and disadvantaged communities to benefit from distributed solar energy.

How does solar for all work?

100% of Solar for All funding will support the low-income and disadvantaged communities that need it most, ensuring that the program benefits flow to the most overburdened communities. The average low-income household benefiting from a Solar for All program will experience ~\$400 in annual savings from their electricity bills.

What information does solar for all provide?

It also provides maps of the states covered by multistate grantees , and information that is useful to Solar for All grantees such as examples of position descriptions or requests for proposals for programmatic functions necessary to deploy low-income solar programs.

What is a solar for all grant?

Reaching communities in all states and territories, including in Tribal Lands, maximizing the reach and breadth of Solar for All. Collectively, the 60 Solar for All grant recipients will implement programs that cover all 50 states, the District of Columbia, Puerto Rico, and several territories.



## What is the new solar energy program?

This new program aims to promote clean energy adoption, reduce energy costs, and address environmental justice concerns by ensuring that solar benefits reach underserved populations. As for now, \$7 billion have been allocated to expand access to solar energy for low-income households across the United States.
